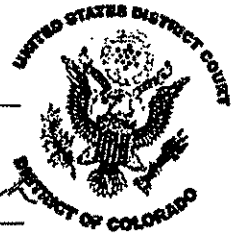

The compact disc containing the results of the June 8, 2007 search was received on June 27, 2007 and the disc was found to contain the following data:

The Toshiba laptop listed an install date of December 20, 2004 and the registered owner as "Scott." The last shut down date was May 5, 2005 and the last login date was February 6, 2006.

Sixty documents were retrieved from the laptop computer which contained: rape video searches on the internet; a login name of "Beefman1996" on the AdultFriendFinder.com website with multiple logins; an online completed sexual preference questionnaire and solicitations for sex with a listing of bondage gear preferred during sex to include handcuffs, shackles, silk scarves, blind folds, collar and leashes; logons to web sites labeled "Maximum Rape", "Rape Photos", "Japanese Girl Rape", "Rape Video Teen Rape", "Rape Island TGP", "Violent Pleasures", "Cruel Families" which included a "Free incest rape video gallery," "Violent Incest" and "Brutally Raped Young Girls." Each of these listed web sites displayed links to access the videos or pictures depicting the scenes advertised.

Multiple press releases and photos of the September 2, 2003 murder of Diane and Alan Johnson in Blaine County, Idaho were retrieved from the computer. Multiple crime scene photographs and the status of that investigation were also captured.

E-mails on a Yahoo! account received by Kimball on or about March 25, 2005 from "xmantats" under the username of Jason Price were captured. Also retrieved were 291 graphic images depicting women clothed and unclothed, being assaulted, forced into violent sexual activities or raped, bound and gagged, feigning or posing as being dead and threatened at gunpoint or knife point. Most such photographs appear to have been downloaded from the internet, though not all could be confirmed as such. The laptop also contained articles and photographs regarding the arrest of the "Bind Torture Kill" or "BTK" subject Dennis Rader, which were also seized.

The Dell tower computer was found to have an install date of March 2, 2005, with the registered owner listed as "Scott." The last logon date was listed as February 6, 2006.

Twenty-six pictures from the Dell were retrieved which pictured various women, one of whom was named "maryland." Multiple photos were taken of this female, some with her clothed, another unclothed. The documents containing Yahoo! e-mail account information regarding Terry Kimball which listed a login date of August 5, 2005 were retrieved, along with an internet

search with the typed terms "Jennifer Marcum missing." A letter which was composed by "Joe Scott" soliciting Brett Gamblin to come to Colorado was also retrieved in the search.
